### How can I help?

- 1 House working days**, usually twice a term on a week-day:
  - indoors small maintenance jobs can include extra cleaning, de-cobwebbing, tidying cupboards, or removing blu-tak and sticky tape from places they shouldn't be.
  - outside there is always tidying to be done, sweeping and weeding paths, cleaning out the Acco drains, cutting back brambles from the paths, and planting bulbs etc.
- 2** The **Lumberjacks** (our outside volunteers) meet once a month at weekends.
- 3** The Friends often help at **Jarman Centre events**:
  - the annual family fun day (usually in May) when we open the centre to the general public for the day;
  - each year we apply to run a charity car boot sale on The Severals in Newmarket – help with stewarding is always welcomed;
  - and we occasionally host activity days for districts, divisions and the county, when extra help is also appreciated.
- 4** New for the Friends: a small amount of **fundraising** to help the Jarman Centre with projects, or even making things to sell in the shop – cards, jams, small knitted items, etc.

All events are friendly and sociable and not too strenuous! You are very welcome at any of the working days.
